

SERVICEMEMBERS/CIVILIANS FAQs

Hurricane Frequently Asked Questions

Service Members:

- Transportation – one round trip to and from approved areas reimbursed at the TDY mileage rate of \$0.535 per mile
- Lodging rate – based on commercial quarters within designated areas (VOCO orders) (receipts required) per JTR 6095-B
- Meals & incidentals per JTR 6095-D1:
 - Over 12 years of age
 - Day 1-30 = 100%
 - Day 31-180 = 60%
 - Under 12 years of age
 - Day 1-30 = 50%
 - Day 31-180 = 30%
- Only applicable to dependents that chose to evacuate. Military member must evacuate if ordered to do so.
- No lodging reimbursement is allowed for staying with friends and relatives per JTR 6095-B1
- Departure and return day per diem is paid at 75%
- Local travel for military dependents - \$25 daily (if dependent is unable to drive POC—no matter the number of dependents) per JTR 6120

Civilians:

- Civilians are authorized travel, lodging, and M&IE if ordered to evacuate by 6 AMW Commander, per JTR 6505-B
- No allowances are provided for home of record releases or telework status
- No entitlements are authorized without 6 AMW Commander authorization, even if local authorities issue evacuation orders
- Transportation – One round trip TDY mileage (\$0.535 per mile) to/from approved areas per JTR 6510D
- Local Travel – not authorized

- Lodging rate – based on commercial quarters within designated areas (VOCO orders) (receipt required) per JTR 6590
- Meals & incidentals per JTR 6590-G & 6595-B:
 - Over 12 years of age
 - Day 1-30 = 100%
 - Day 31-180 = 60%
 - Under 12 years of age
 - Day 1-30 = 50%
 - Day 31-180 = 30%
- Only applicable to civilians/dependents that chose to evacuate upon receipt of orders
- Regular salary continues throughout the evacuation
- No lodging reimbursement is allowed for staying with friends and relatives
- Departure and return day per diem is paid at 75%

1. What is not authorized?

- Government Travel Card (GTC) is not authorized to protect or prepare homes or personal property
- GTC charges cannot be incurred prior to evacuation order being issued
- Locality rates apply to designated evacuation areas
- Receipts are required for lodging and any charges \$75 or more
- No lodging reimbursement for staying with friends and relatives
- Departure and return day per diem is paid at 75%

2. If I am a contractor, do I receive entitlements for evacuating like the government employees do?

The government does not cover entitlements for contractor employees. Speak with your task lead for your contracting company to see what the company provides.
