Upon sending the 3<sup>rd</sup> request to the KO also sent the request to a SDVOB, Purple Shovel, for pricing. Purple Shovel has known capabilities to be able to ship to remote locations in the AOR. The 3<sup>rd</sup> revision to the proposal was received on April 14<sup>th</sup>, 3 months after the items were originally requested. The proposal from Purple Shovel was received at the same time only 4 days after the pricing was requested.
