Subj: LIST OF ESTABLISHMENTS DECLARED "OFF-LIMITS" IN THE OAHU  
AREA TO ALL ACTIVE DUTY NAVY PERSONNEL

Ref: (a) AR 190-24/OPNAVINST 1620.2A/AFI 31-213/MCO 1620.2D/ COMDTINST  
1620.1E of 27 Jul 06

1. Purpose. Promulgate off limit establishments to active duty Navy military personnel.
2. Information. Reference (a) authorizes the formation of the Hawaii Armed Forces Disciplinary Control Board (AFDCB) to advise and make recommendations on Oahu establishments that affect Navy personnel health and welfare.
3. Off-Limits Establishments. Per AFDCB, the below locations are "off-limits" to active duty Navy personnel.

4. Restriction. All active duty Navy personnel are prohibited from entering any establishment or attending any event sponsored by the businesses listed above unless required by competent authority. Active duty Navy personnel, whether in uniform or in civilian clothing, found entering or leaving any of these establishments or events may be subject to disciplinary action under the Uniform Code of Military Justice (UCMJ).
5. Punitive Provision. This notice constitutes a general order or regulation within the meaning of UCMJ, Article 92 and any violation of this notice may result in punitive action under the UCMJ, adverse administrative action, or both.
6. Dissemination. Wide dissemination to ensure maximum awareness and compliance.
7. Records Management. Records created as a result of this notice, regardless of media or format, must be managed per Secretary of the Navy Manual 5210.1 of January 2012.
8. Cancellation Contingency. This notice shall remain in effect until superseded by another notice bearing the same subject.
